The meeting is organized based on the specific interest of the RECP Network members to receive first-hand, practical information on the implementation of the RECP measures in Demonstration Companies and RECP Clubs Companies in the period 2014-2023. The participants will discuss both the results achieved from the implementation of the RECP measures as well as the most typical difficulties and challenges faced in the course of the implementation process.

The meeting will gather about 30-35 participants from the RECP Clubs and RECP Demonstration Companies, RECP Experts, representatives from the companies engaged in the project, the representatives of the RECP companies from a previous EU-funded programme, EaP GREEN, and the representatives of SMEs interested in the practical implementation of the RECP methodology in the country.

Background

The national RECP network has been formed upon the completion of the RECP training and coaching for RECP Clubs companies and Georgian experts. Its purpose is to strengthen the national capacity and collaboration on RECP in the country. The Network was envisioned as platform to help expand knowledge and build capacity by leveraging relationships between professionals, enhancing communication and knowledge sharing among experts, business owners, and stakeholders interested in RECP in Georgia.

For the organization of regular RECP Network meetings (2-3 times per year) to discuss the most interesting issues/topics, to explore local needs, to share national good practice and approaches, to introduce new/updated legislative obligations or standards, to discuss the most topical issues affecting the business sector, etc. a survey among RECP demonstration and RECP Clubs' member companies for the identification and prioritization of topics of interest for the companies was held.
